Datafile Notes

September 2008

We are pleased to bring you the latest preliminary data from the 2007 Biennial Reporting System for the following states: Alabama, Florida, Georgia, Kentucky, North Carolina, Ohio, Tennessee and Utah. Look for new states on the December HazSearch CD. As always, this data includes *allowable, not necessarily correct values*, and should be viewed accordingly.

New!⇒Alabama Draft BRS 2007

Below is a chart that compares total waste received from off site by some of the larger TSDs in Alabama with what they received in 2005:

The inflated figure for Giant appears to be the result of a data entry error at this time, due to a shipment from Chemcraft Systems (ALD063680391) amounting to 368,372 tons, which may, in fact, turn out to be pounds.

Alaska Final BRS 2005

Off-site TSD totals are 1,353 tons compared to 2,643 tons in the 2003 data.

Arizona Final BRS 2005

The total amount of off-site waste in this draft is indicative of the declining amount of waste shipped off site. Currently the off-site TSD receipts amount to 55,316 tons. However, World Resources (AZD980735500) is reporting 26,157 tons, which is roughly in line with 2003 receipts.

Arkansas State Annual 2006

Off-site shipments amount to 515,174 tons. Rineco is reporting 94,951 tons versus 79,551 tons in 2005. Ash Grove Cement is reporting 108,034 tons, due mainly to large shipments from other TSDs. Clean Harbors Environmental Services, formerly Teris, is

reporting 51,860 tons and reported 50,429 tons in 2005. About 6,000 tons is being shipped by Arkansas generators to Mexico. To search for these generators type in FCMEXICO0000 as the facility EPA ID.

New!⇒California State Annual 2007

The off-site TSD totals are 2,939,231 tons compared to 3,099,862 tons in 2006. Below is a table comparing some of the major receiving sites in California.

Colorado Draft BRS 2007

Off-site TSD totals stand at 64,642 tons compared to 62,684 tons in the 2005 BRS data. Clean Harbors Deer Trail (COD991300484), stands at 18,744 tons compared to 4,315 tons in 2005. Veolia Environmental Services (COD980591184), formerly known as Onyx Environmental Services is showing 13,938 tons, which is down somewhat from the 17,599 tons reported in 2005.

Connecticut Final BRS 2005

The large shipment record, 13,765,000 tons, from Indalex (CTD024539967) to United Oil Recovery (CTD021816889) which skews the off-site totals for this state has now been removed from the final data. The off-site TSD totals now amount to 68,807 tons.

Delaware Final BRS 2005

The off-site totals for 2005 are 14,635 tons compared to 15,810 tons in the 2004 state annual report.

New!⇒Florida Draft BRS 2007

Overall off-site TSD totals are somewhat higher in this draft data than in 2005 due to a shipment of 42,000 cubic yards from Windsor Metal Specialities (FLD984241414) to Giant Resource Recovery (ALD070513767). Approximately 4,500 tons of waste is shipped to Mexico. Use FCMEXICO0000 as the facility EPA ID number to search for Florida generators shipping to Mexico.

New!⇒Georgia Draft BRS 2007

Ramsey Chemical (FKA Perma Fix) (GAD093380814) is reporting 254 tons in this draft data compared to 4,203 tons in 2005. Onyx (GAD096629282) is currently showing 345 tons compared to 899 tons in 2005.

Iowa Draft BRS 2007

The largest receiver of waste from Iowa generators, Peoria Disposal (ILD000805812) is reporting 29,434 tons, which is in line with the 29,496 tons reported in 2005. Overall off-site TSD totals for the state are 52,507 tons compared to 57,691 tons in 2005.

Idaho Final BRS 2005

Off-site TSD totals are 142,717 tons compared to 132,939 tons in the 2003 data. US Ecology Idaho (IDD073114654) is reporting 113,454 tons

Illinois Final BRS 2005

The off-site TSD totals are 750,961 tons compared to 838,454 tons in 2003. The Illinois receiving sites are reporting receipts which are in line with previous years.

Indiana State Annual 2006

Off-site TSD totals are substantially lower—more closely in line with figures for 2002—at 400,621 tons. This data also includes who transported the waste.

Iowa Final BRS 2005

Off-site TSD totals stand at 57,691 tons compared to 50,110 in 2003. By that standard, that would indicate that this data is in reasonably good shape.

Kansas Draft BRS 2007

Our data source tells us that Systech did not claim CBI (Confidential Business Information) this reporting cycle.

Off-site TSD totals for 2007 are 377,849. LaFarge Midwest (KSD007148034) stands at 94,049 tons and Ash Grove Cement (KSD031203318) is reporting 48,532 tons, which is essentially in line with 2005 data. Systech (KSD980633259) is reporting 80,816 tons.

New!⇒Kentucky Draft BRS 2007

Off-site TSD totals are somewhat lower than in the 2005 data—242,697 tons compared to 270,373 tons.

Louisiana 2006 State Annual

The double reporting for the Shell Norco Chemical Plant under two similar EPA ID numbers has returned and that TSDF is now reporting under the LAR000042226 number and LAD000042226 number in this data. Disregard tonnages associated with LAD000042226 as this is duplicate data. The off-site shipments (disregarding tonnages shipped to the erroneous number) amount to 465,065 tons compared to 494,248 tons in 2005.

Maine Final BRS 2005

Two data entry errors which skewed Maine's off-site TSD totals have now been removed in this final data.

Maryland Final BRS 2005

Shipment records we warned about in the draft data have now been removed from the final data. The off-site TSD totals for Maryland are 198,778 tons.

Massachusetts Final BRS 2005

We have been informed by Region 1 that Clean Harbors of Braintree (MAD053452637) is claiming confidentiality so some of the generators' identities are masked. For those of you with multiple-state coverage, put a check mark in Select Data from Generator State Files to get a more complete picture of generators shipping to this EPA ID number.

Michigan Final BRS 2005

The off-site TSD totals are lower (643,481 tons) than they were in 2003 (1,378,362 tons). Please see the table below for a comparison of amounts received by Michigan TSDs in 2005 and the 2003 data.

Minnesota Final BRS 2005

Off-site totals are much higher than in previous years—354,211 tons compared to previous years where around 200,000 tons has been the norm. Much of this increase is accounted for by waste taken in by Gopher Resource Corp. (MND006148092), which reports receipts of 267,034 tons.

Mississippi Draft BRS 2007

The off-site TSD totals are 76,505 tons compared to 67,898 tons in the 2006 data. Holcim (US) Inc. (MSD077655876) is reporting 55,646 tons compared to 47,053 tons in the 2006 state annual reporting data.

Missouri Draft BRS 2007

Note: Information for Solvent Recovery (MOD000610766) and Waste Express (MOD981123391) is not included in the data at this time.

However, it does appear that the tonnages received by Lone Star Industries (MOD981127319) and Green America Recycling (MOD054018288), formerly known as Continental Cement, are closely in line with what was reported in the 2005 reporting cycle. Holcim US Inc. Geocycle LLC (MOD029729688), reporting 27,373 tons, appears down substantially from the 56,561 tons reported in 2005.

Nebraska Draft BRS 2007

Off-site TSD totals for 2007 are 72,157 tons compared to 72,587 tons in 2005. The largest receiving site, Clean Harbors (NED981723513) is reporting 32,067 tons, which is slightly lower than the 38,772 tons reported in 2005.

Nevada Final BRS 2005

US Ecology (NVT330010000) reports receiving 51,464 tons compared to 34,393 tons in 2003. The off-site TSD totals are up somewhat at 70,886 tons compared to 65,028 tons in 2003.

New Hampshire 2007

Off-site TSD totals are down somewhat over last year. They stand at 7,926 tons compared to 11,405 tons in 2006 with 1,073 tons being shipped to Stablex Canada (NYD980756415).

New Jersey 1st, 2nd and 3rd Quarters 2007

NOTE: *Since we don't have the full year for 2007 we have retained 2006 on the CD. Be sure to specify a year when search New Jersey or you will get data for both 2006 and 2007.*

In the first and third quarters there are very large shipments from USEPA Region II (NJ0001900281) to Canada (CANA00000018) which skew the overall off-site TSD tonnage amounts.

In the second quarter there is a very large shipment from 425/445 Rt. 440 Property LLC (NJD986581437) to US Ecology (IDD073114654) which also skews tonnage amounts for that quarter. Otherwise, New Jersey TSDs appear to be within normal ranges.

New Mexico Final BRS 2005

Shipments amounting to 8,426 tons to the US DOE Isolation Pilot Plant (NM4890139088) contributed to a 50% increase in the waste amounts included in this data.

New York 1st, 2nd & 3rd Quarters 2006

The off-site shipments for the second quarter seem high to two out-of-state TSDs: Michigan Disposal (MID000724831) and Clean Earth of North Jersey (NJD991291105). The data shows two shipments of 46,000 tons—perhaps duplicates—from Lockheed Martin (NY0000382010) to the Michigan site. Also, there is one shipment of 31,920 tons from NYCDOT Queensboro Bridge (NYR000010363) and one shipment of 28,260 tons from NYCT-Astoria Linebents (NYR000110593) going to the New Jersey site.

New!⇒North Carolina Draft BRS 2007

The off-site TSD totals are 564,379 tons compared to 185,240 tons in the 2005 data. This is due to a shipment record of 490,293 tons going from Detrex (NCD049773245) to Safety-Kleen (OHD980587364).

North Dakota Draft BRS 2007

There appears to be a substantial error (31,750,092 tons) in the amount shipped to Waste Recovery Systems (NDD982591794). This TSD reported only 351 tons in 2005.

New!⇒Ohio Draft BRS 2007

Our source for this data asked that we make you aware that not all the data is in yet, however most of the important reporting sites are present in the data at this time. In fact, the off-site TSD totals in this draft data compare favorably with 2006—1,400,468 tons compared to 1,627,808 tons.

Oklahoma Final BRS 2005

The off-site TSD totals are 91,284 tons compared to 105,711 tons in the 2003 data. Clean Harbors Lone Mountain (OKD065438376) is reporting 44,223 tons. Perma-Fix (OKD000402396) is reporting 11,531 tons.

Oregon Final BRS 2005

Chemical Waste Management of the NW (ORD089452353) is the largest hazardous waste receiver in the state reporting 92,777 tons out of the 122,791 tons of off-site waste in the Oregon data.

Pennsylvania Final BRS 2005

Two large shipment records we cautioned you about in the draft data have now been removed.

Off-site TSD totals are 965 tons compared to 1,610 tons in 2005.

New!⇒Tennessee Draft BRS 2007

Off-site TSD totals are 80,286 tons compared to 88,798 tons in 2005. Pollution Control Industries (TND000772186) is reporting 28,705 tons compared to 20,255 tons in 2005.

New!⇒Texas State Annual 2007

Total individual receipts for the major commercial hazardous waste receiving sites in Texas are roughly in line with previous years. Overall off-site TSD totals stand at 4,984,641 tons in 2007 compared to 3,237,320 tons in 2006 and 4,475,890 tons in 2005.

Texas State Waste Codes

If a RCRA code is not provided for an eight-digit Texas waste code, HazSearch reports only the last four digits of the eight-digit waste code in the **FWC** field (three-digit form

code plus the one character waste classification code—H for hazardous and 1 for non-hazardous.)

Off-site TSD totals stand at 163,122 tons.

Vermont 2005

Off-site shipments amount to 9,919 tons compared to 10,756 tons in 2004. The receiving site receiving the most waste from Vermont generators was the Stablex facility in Canada. Vermont is using the EPA ID number NYD980756415 to identify this TSD.
